## Introduction

English for the Financial Sector is a course for business students and people working in the financial industry with an intermediate or upper-intermediate level of English.

#### The course aims to:

- · explain the basic concepts of most areas of finance
- build your financial vocabulary through reading, listening and discussion
- develop your comprehension of financial texts
- · develop your listening skills in financial English
- improve your speaking skills through discussion, case studies and role plays
- develop your business communication proficiency by increasing your confidence and fluency in a range of skills
- practise specific language functions such as advising, suggesting, agreeing and disagreeing, clarifying, reviewing, and summarizing.

The course consists of 24 units.

The **odd-numbered units** cover a particular area of finance, such as retail banking, investment banking, trade finance, asset management and accounting. They include authentic interviews with people working in finance, authentic business reading texts, and comprehension, vocabulary and discussion activities.

The **even-numbered units** practise business communication skills – telephoning, socializing, participating in meetings, writing letters, emails and reports, negotiating, and making presentations – in a financial context.

Each unit has a **Language focus** section looking at a specific language area and **Practice** activities using realistic situations from the financial industry.

The listening material includes British, American, European and Indian speakers. Tapescripts of all the listening material are included at the end of the book.

If you are still studying business or finance, you may learn new financial concepts from this book. If you are already working in finance, you will be able to use your knowledge and experience in the activities and exercises in this course.

You will probably be using this book in a class with a teacher. If so, try to participate as much as possible in the pair work and group activities, as this will increase the time you spend practising speaking, and so improve your fluency and confidence.

I hope you enjoy using this book.



### **Regulation and deregulation**


In the late 1920s, several American commercial
banks that were (1) security

<sup>\*</sup> Z is pronounced zee in American English and zed in British English.



When we read long strings of numbers, such as telephone numbers, passport numbers, credit card numbers, and car registration numbers, we usually say each digit separately.

Example:

You can phone him on 001 202 456 1414.

British English:

oh oh one, two oh two, four five six, one four one four

American English:

zero zero one, two zero two, four five six, one four one four

An exception to this is 'double numbers':

944 2299

nine double four, double two double nine

944 2229

nine double four, double two two nine

However, we do <u>not</u> usually say *double oh* or *double zero* at the beginning of an international number.

When saying numbers, we use a rising intonation for every group of numbers except the last one, when we use a falling tone. This shows we have reached the end of the number.



## Banks to rely on branches to drive growth

By Jane Croft

Banks will rely on branches to drive future growth rather than the internet, according to new research.

A study of 2,709 customers by Deloitte & Touche, the professional services firm, showed that the bank branch is the preferred channel for 52 per cent of customers interviewed.

Only 16 per cent preferred to bank

using the telephone and 8 per cent used the internet.

The study also showed that the bank branch is preferred by 45 per cent of customers in the affluent AB social group – contradicting the notion that sophisticated customers avoid branches.

Nick Sandall, retail financial services partner at Deloitte & Touche, said he believed that the main banks in the UK were planning to reverse a decade of under-investment in branches by putting the network at the heart of their strategy.

'Although some banks, such as Abbey National, are ahead of the

game in their efforts to revolutionise the way in which they use branches to reach the consumer, we expect all banks to invest substantially in reshaping their branch networks and the activities within,' he said.

Deloitte & Touche believed that the successful retail bank of the future needed to give careful consideration to areas such as branch design, staffing and location.



#### Leaving out words

Although spelling and punctuation should usually be correct – an email is <u>not</u> a text message – emails between friends and colleagues are sometimes written like telegrams used to be, with unnecessary words left out. The full grammatical form is not necessary if the meaning is clear from the context.

People also often use acronyms (the first letters of words) such as TIA (thanks in advance), asap (as soon as possible), FYI (for your information), BTW (by the way) and BW (best wishes). In informal emails, people writing quickly often use short forms of common words: yr, pls, thx or thnx, rgds, re (your, please, thanks, regards, with reference to). It's worth remembering that using acronyms and short forms might be considered unprofessional in some business situations, especially when you do not know the person you are writing to very well.







**Corporate bonds** are issued by companies to raise capital. They are an alternative to issuing new shares on the stock market (equity finance) and are a form of debt finance. A bond is basically an IOU (short for 'I owe you') – a promise to pay back your original investment (the 'principal') at a maturity date, plus interest payments (the 'yield' or 'coupon') at regular intervals between now and then. The bond is a tradeable instrument in its own right, which means that you can buy and sell it during its life, and its value will tend to rise and fall as interest rates change.

Thirty or forty years ago, large companies that wanted to borrow money generally got loans from banks. Then they discovered that they could borrow at a lower rate by raising money directly from the public (and from institutional investors like insurance companies and pension funds), by issuing bonds. This process of disintermediation – cutting out the intermediary (the bank) between the borrower and the lenders – is obviously *not* a good thing for commercial banks. They now have to lend their money to borrowers that are less secure than large corporations.



On the other hand, companies use investment banks to issue their bonds for them, permitting banks to make money from fees rather than from interest.

#### Formal and informal style 2

Business letters, sent from one company to another, or to clients and customers, are generally written in a very polite, formal style. However, it is not only letters that are written this way: the first contact between a company and a business partner is generally written in a formal style, even if it is an email. Subsequent correspondence between people who know and like each other often becomes less formal, using the style discussed in **Unit 4**. Such correspondence is increasingly done by email rather than letters (posted by 'snail-mail').



### Reading: The Bank of England

The Bank of England has two (1) purposes. One is ensuring monetary stability, i.e. having stable prices – low (2) – and consequently confidence in the currency.

UK banks and building societies have to hold reserves at the Bank. These are (4) at the Bank's official interest rate. If British banks need to borrow short-term funds they do this in the (5) money markets.

The Bank also deals in the foreign exchange market. It can use the UK's foreign currency and gold reserves to try to influence the exchange rate if needed.
The Bank's other core purpose is to maintain the stability of the financial system. The Bank has to detect and reduce any (7) to financial stability, and make sure the overall system is safe and secure. It monitors and analyses the behaviour of the major participants in the financial system and the wider financial and economic environment, and tries to identify potential risks. ### Talking about figures 2

When discussing interest rates and monetary policy, you need to know how to say decimal numbers.

English uses a symbol like a full stop between the two parts of a decimal number. It is called a decimal point. A comma is not used in this position. In a pure number (without a unit of measurement), each digit after the decimal point is said separately.

Examples: 3.5 three point five

> 3.51 three point five one (not three point fifty-one)

3.14159 three point one four one five nine

3.75% three point seven five percent

However, if the number after a decimal represents a unit of money, length, etc., it is usually read as a normal number.

Examples: \$5.61 five dollars sixty-one (cents)

> 1.22 m one metre twenty-two (centimetres)

0 is called zero or (mainly in British English) nought. British English also uses oh, but only after the decimal point, never before.

Examples: 11.005 eleven point oh oh five (or eleven point double oh five)

> 0.501 zero / nought point five oh one

0.001 zero / nought point oh oh one (or zero / nought point double oh one)



If the documents are in order, the advising bank sends them to the issuing bank for payment or acceptance. If the details are not correct, the advising bank tells the seller and waits for corrected documents or further instructions.


The advising/confirming bank pays the seller and notifies him or her that the payment has been made.

The issuing bank advises the advising (or confirming) bank that the payment has been made.

The issuing bank (the buyer's bank) examines the documents from the advising bank. If they are in order, the bank releases the documents to the buyer, pays the money promised or agrees to pay it in the future, and advises the buyer about the payment. (If the details are not correct, the issuing bank contacts the buyer for authorization to pay or accept the documents.) The buyer collects the goods.

The seller presents the documents to his or her bankers (the advising bank). The advising bank examines these documents against the details on the letter of credit and the International Chamber of Commerce rules.

When the seller (beneficiary) is satisfied with the conditions of the letter of credit, he or she ships the goods.



### **Introducing Incoterms**

Incoterms – short for 'International Commercial Terms' – are standard trade definitions devised and published by the International Chamber of Commerce (ICC). They are an internationally recognized code that simplifies trade between different countries.

Incoterms identify the additional costs, over and above the cost of the goods, that the seller will invoice the buyer in international sales contracts. They define who is responsible for arranging and paying for transportation, documentation, customs clearance and transport insurance.

There are 13 different Incoterms, grouped into 4 different categories.

**Group 1 – The E Term (Departure)** 

EXW – Ex Works (named place)

Under this shipping term the seller makes the goods available for collection by the buyer at the seller's own premises. The buyer arranges insurance against damage to the goods in transit.

This term involves the least risk for, and requires the least effort by, the seller, but should not be used where the buyer cannot carry out export formalities.

Group 2 - The F Terms (Free, main carriage not paid by the seller)

FCA - Free Carrier (named place)

FAS – Free Alongside Ship (named port of shipment)

FOB - Free On Board (named port of shipment)

The seller arranges and pays for the pre-carriage in the country of export. The goods are delivered to a carrier appointed by the buyer. The buyer arranges insurance against damage to the goods in transit.

Group 3 – The C Terms (Main carriage paid by the seller)

CFR – Cost and Freight (named port of destination)

CIF – Cost, Insurance and Freight (named port of destination)

CPT – Carriage Paid To (named place of destination)

CIP – Carriage and Insurance Paid To (named place of destination)

In this group the seller arranges and pays for the main contract of carriage.

In the terms CIF and CIP the seller arranges insurance against damage to the goods in transit.

Group 4 - The D Terms (Delivered/Arrival)

DAF - Delivered At Frontier (named place)

DES – Delivered Ex Ship (named port of destination)

DEQ – Delivered Ex Quay (named port of destination)

DDU - Delivered Duty Unpaid (named place of destination)

DDP - Delivered Duty Paid (named place of destination)

These terms maximize the seller's cost and risk, as he has to make the goods available at the agreed destination. The seller bears the costs and risks of bringing the goods to the country of destination, and arranges and pays for insurance against damage to the goods in transit.





### **FX Trading**

The Foreign Exchange market, also referred to as the 'Forex' or 'FX' market, is the largest financial market in the world, with a daily average turnover of well over US\$1 trillion – 30 times larger than the combined volume of all U.S. equity markets.

Foreign Exchange is the simultaneous buying of one currency and selling of another. Currencies are traded in pairs, for example Euro/US Dollar (EUR/USD) or US Dollar/Japanese Yen (USD/JPY).

There are two reasons to buy and sell currencies. About 5% of daily turnover is from companies and governments that buy or sell products and services in a foreign country or must convert profits made in foreign currencies into their domestic currency. The other 95% is trading for profit, or speculation.

For speculators, the best trading opportunities are with the most commonly traded (and therefore most liquid) currencies, called 'the Majors'. Today, more than 85% of all daily transactions involve trading of the Majors, which include the US Dollar, Japanese Yen, Euro, British Pound, Swiss Franc, Canadian Dollar and Australian Dollar.

A true 24-hour market, Forex trading begins each day in Sydney, and moves around the globe as the business day begins in each financial center, first to Tokyo, London, and New York. Unlike any other financial market, investors can respond to currency fluctuations caused by economic, social and political events at the time they occur – day or night.

The FX market is considered an Over The Counter (OTC) or 'interbank' market, due to the fact that transactions are conducted between two counterparts over the telephone or via an electronic network. Trading is not centralized on an exchange, as with the stock and futures markets.



### Why stock markets matter for you Stefan Armbruster, BBC News online

The saying goes: 'Don't invest what you can't afford to lose'.

But as stock markets fall, it is not just people who own shares who lose out. When the bears replace the bulls – in other words, when the market falls – it affects almost everyone because stocks and shares have become an integral part of almost all our financial lives.

There are a variety of ways in which stock market movements impact on our lives. The upbeat side of the growth in share ownership is that when the stock market goes up, consumers with shares feel richer, they borrow more and they spend more. But just as the stock market can go up, it can also go down. Usually the first to react to this are the institutional investors who are involved in the financial markets on a daily basis.

The internet boom is an example. Many personal investors felt they were burnt by the popping of the dot.com bubble. By the time they got around to selling shares in any number of failing internet based companies, the big City investors had already pulled out of the market. The institutional investors did not escape unharmed either. And the hits that they took also have an indirect, but potentially serious, effect on many people's financial health. Any pain suffered by these institutional investors impacts on the returns paid on pensions, savings accounts or the interest charged on mortgages.

For individuals with a more direct interest – say day traders attracted by the tech boom – share holdings can be used as collateral to borrow money. But if the value and income from shares evaporate and the bank calls in the loan, the result can be big losses or personal bankruptcy. Meanwhile pensions linked to the stock market, like the ones being promoted by the UK government, are not immune. Unlike the state pension which is paid out at a rate set by the government, investing in a private pension indexed to the stock market can increase the value of the contributions dramatically, but they can also be erased.

Your job can also depend on the markets as companies use their valuation and the issue of new shares to raise capital to expand. If they are unable to do this then they have to find ways of increasing the company's value to attract investors. The key tool they use is to cut jobs. ▶

Corporate raiders making a comeback

- a Successful companies generally want to diversify: to introduce new products or services, and enter new markets. Yet entering new markets with new brands is usually a slow, expensive and risky process, so buying another company with existing products and customers is often cheaper and safer. If a company is too big to acquire, another possibility is to merge with it, forming a new company out of the two old ones. Apart from diversifying, reasons for acquiring companies include getting a stronger position in a market and a larger market share, reducing competition, benefiting from economies of scale, and making better use of plant and equipment.
- b There are two ways to acquire a company: a raid and a takeover bid. A raid simply involves buying as many of a company's stocks as possible on the stock market. Of course if there is more demand for stock than there are sellers, this increases the stock price. A takeover bid is a public offer to a company's stockholders to buy their stocks at a certain price (higher than the current market price) during a limited period of time. This can be much more expensive than a raid, because if all the stockholders accept the bid, the buyer has to purchase 100% of the company's stocks, even though they only need 50% plus one to gain control of a company. (In fact they often need much less, as many stockholders do not vote at stockholders' meetings.) If stockholders accept a bid, but receive stocks in the other company instead of cash, it is not always clear if the operation is a takeover or a merger journalists sometimes use both terms.
- c Companies are sometimes encouraged to take over other ones by investment banks, if researchers in their Mergers and Acquisitions departments consider that the target companies are undervalued. Banks can earn high fees for advising on takeovers.
- d Yet there are also a number of good arguments against takeovers. Diversification can damage a company's image, goodwill and shared values (e.g. quality, good service, innovation). After a hostile takeover (when the managers of a company do not want it to be taken over), the top executives of the newly acquired company are often replaced or choose to leave. This is a problem if what made the company special was its staff (or 'human capital') rather than its products or customer base. Furthermore, a company's optimum size or market share can be quite small, and large conglomerates can become unmanageable and inefficient. Takeovers do not always result in synergy. In fact, statistics show that most mergers and acquisitions reduce rather than increase the company's value.



Stockholder value: was the company's stock price higher 12 months after the merger or acquisition, compared with the overall trend for the industry?

A survey of the 700 largest international merger and acquisition deals during a three-year period showed the following:

In 17% the deal created value. In 30% the deal neither created nor destroyed value. In 53% the deal destroyed value.

e Consequently, corporate raiders and private equity companies look for large conglomerates (formed by a series of takeovers) which have become inefficient, and so are undervalued. In other words, their market capitalization (the price of all their stocks) is less than the value of their total assets, including land, buildings and – unfortunately – pension funds. Raiders can borrow money, usually by issuing bonds, and buy the companies. They then split them up or sell off the assets, and then pay back the bonds while making a large profit. Until the law was changed, they were also able to appropriate the pension funds. This is known as asset-stripping, and such takeovers are called leveraged buyouts or LBOs. If a company's own managers buy its stocks, this is a management buyout or MBO.





A few tips.

Be prepared. Before you negotiate, know exactly what you want and be ready to articulate your position; a negotiating meeting is no place to figure out the terms that are acceptable to you. You won't get every deal point, but at least you'll know in advance what are your parameters. In fact, it helps to break down your concerns into three categories: nice to have, like to have, and must have. Walk through several 'what if' scenarios beforehand. Anticipate counter-proposals and compromises and think about how you will react to each.

Be inquisitive. Don't be shy about asking questions. Skilful questions can transform a negotiation from an adversarial conflict into a partnership. By asking questions, you'll also get your client to reveal more. Start with open-ended questions and move to narrower, more direct questions. Once you have asked a question, be quiet and listen carefully.

Avoid significant early concessions. At the very least, remain neutral to the customer's initial demands until trade-off opportunities emerge or your gentle attempts at persuasion don't work.

Be prepared for disagreement. There will be disagreement and disappointment during any negotiation. But how you disagree will affect the outcome and ultimately affect your relationship with the client. When you disagree, look for the common ground or set the point aside until later. At the end of your discussions, you may find you have four or five points of disagreement. You can then exchange deal-point concessions until all points of contention are dealt with.

Expect the unexpected. Always have a good idea in advance of how you'll respond if things do not work out as you plan.

Finalize all agreements. Don't leave details hanging. It is often amazing how two people sitting in the same room can have different perspectives concerning what was agreed upon. To ensure that everyone is clear, summarize the agreement verbally or shortly afterward in a letter of agreement.



Derivatives is a collective term for financial market products whose value depends on (i.e. is derived from) the price of another underlying asset such as a stock, a stock index (the average value of representative stocks in a given market), a currency, a commodity, etc. The main derivatives are futures, options and swaps. They were developed to allow companies to reduce uncertainty by guaranteeing future prices, at a reasonable cost. This allows companies to plan more effectively.

Futures contracts are agreements to make or take delivery of specified commodities (foodstuffs, metals, etc.) or financial instruments at a fixed future date, at a price determined when the contract is made. Futures contracts allow both sellers and buyers to hedge or reduce risks. For example, a cocoa grower can agree a price, quantity and delivery date with a chocolate manufacturer. The seller eliminates the risk that the price will drop, and the buyer the risk that it will rise. The same logic led to the development of financial futures: contracts to buy and sell stocks, stock indexes, interest rates and currencies at a future date.

Options differ from futures in that they give the right, but *not* the obligation, to buy or sell an asset at a fixed price on or before a given date. Buying a call option gives you the right to buy an asset; buying a put option gives you the right to sell an asset. For example, if you expect the price of a stock to rise you can buy the right to buy that stock in the future at the current market price. If you think the price of a stock will fall in the next few weeks or months you can buy the right to sell it in the future at the current price. If you are wrong, you do not have to exercise the option to buy or sell the stocks, but you lose the price of the option. This is the premium the writer or seller of the option receives from the buyer. Obviously, the expectations of the writer of an option about the future value of the assets are opposite to those of the buyer, and the writer does not expect the option to be exercised. Futures and options are traded by speculators hoping to make a profit from price fluctuations, as well as by companies seeking to hedge. In fact, much more derivative usage is based on speculation than hedging nowadays.

Borrowers and lenders can also swap or exchange future interest payments. A company that has borrowed money at a floating rate could protect itself from a rise in interest rates by exchanging this for a fixed interest rate loan with another company or financial institution. These are interest rate swaps. Companies can also undertake exchange rate swaps, exchanging funds in two different currencies. At a future date the same amount of the currencies is re-exchanged at a predetermined exchange rate. Over the term of the agreement, the counterparties exchange fixed or floating rate interest payments in their swapped currencies.







### Fund management: Mug's game

Anger is growing with those who manage money, particularly with those poorly performing active managers who claimed that it was precisely during tough times that they would come into their own against indexed funds. In Britain, two-thirds of active managers underperformed the index last year, even before the fees that they charged are subtracted. Those people are handsomely rewarded for losing money. Each year they pocket 1–2% of the assets they manage, on top of initial charges of as much as 5%. Indexers, by contrast, charge only 0.5% a year, with no upfront fees.

An average fund manager will beat the market some of the time. Over the long run, though, the great majority of fund managers will do no better than the market average, particularly once their charges are taken into account. The chances are slim of finding one of those blessed few who can show real, sustained skill in stockpicking. Even if you find one, you may discover that what made him good in one economic period will serve him less well in the next.

Believers in the so-called efficient-market hypothesis, developed by American economists in the 1960s, have tried to demonstrate the impossibility of consistent outperformance. They argue that all useful information that is available to market participants is already factored into a company's share price. Additional analysis of a share by, for instance, taking a closer look at a company's books or talking to its management – as well as all attempts at discovering patterns in price movements

will be futile. This theory opened the door to those offering merely to track the index. Index-tracking grew hugely during the bull market of the 1980s and 1990s. In the bear market of the past two years, people have not pulled out much money from index funds – or at least, not yet.

Not everybody buys the efficient-market hypothesis, however. George Soros, a well-known speculator, thinks he made his money because markets often over- or undervalue things. He also challenges the view that share prices are simply a passive reflection of underlying value, or of the expected earnings of a company. A high share price might, for example, trigger certain actions: a public offering of a company's shares, or a merger or an acquisition. A low share price, meanwhile, might stop plans for an initial public offering or a merger. This is what Soros calls the market's 'reflexivity'.

If knowledge of such a two-way relationship between share prices and assets can be put to good use, a fund manager might consistently do better than the market. Peter Lynch, formerly of Fidelity Investments, showed that a more old-fashioned technique – looking for good companies that the market fails for a time to appreciate – can also outperform. Yet a few examples among a cast of many thousands of fund managers offer only small consolation to the average investor, who will almost always be better off – or these days, rather worse off – putting his money in an index fund.





#### Reading: Conflicts of interest

Conflicts of interest are situations in which what is good for one department of a financial institution and its customers is not in the best interests of another department and its customers. Such conflicts are almost inevitable in financial institutions.



### Dealing with questions and troubleshooting

#### Dealing with questions

The question and answer section can be the most difficult part of a presentation because you can't prepare for it.



### Here are some tips:

- Welcome questions and listen carefully (and look at the questioner).
- Do not interrupt the speaker.
- Clarify the exact meaning of the question if you are not sure.

#### Examples:

Sorry, I didn't catch that. Could you repeat that please? Sorry, I'm not sure if I've understood exactly ... If I've understood you correctly, you want to know ... Is that right?

- Take time to think (though not too long) before you answer, if necessary.
- Be as brief and direct as possible.
- Be polite.
- Check that your questioner is satisfied with your answer.

### Examples:

Have I answered your question? Does that answer your question?

#### Sometimes, it is impossible to answer a question, because:

- a It is not relevant to your presentation
- You simply don't know the answer
- You don't want to give the information



You work for MGS Bank and you have called a meeting with the management team of Capper Trading.

The bank is considering granting the loan, depending on the conditions the company accepts. However, you think there is a considerable risk involved. If the toys stop selling, the company could have paid for 100,000 unwanted imported toys, on top of the 20,000 a week it is manufacturing itself. Under these conditions, you need to charge a high interest rate, and prefer an arrangement that gives you greater security.

You are prepared to offer EITHER a three-month loan at 3% (i.e. 12% per annum), which could be renewed or renegotiated if the product continues to sell, OR a one-year 9% loan that is secured by specified assets: if the company cannot repay the loan, you can oblige them to sell some of their assets, including their machinery and the factory they are in.

You would add a penalty clause: 1.2% per month for any loan not repaid on time.

You would charge your standard arrangement fee for loans over £50,000, which is 1.25%, plus a standard prepayment fee, which is 1% of the amount lent.

You would require the company to provide up-todate sales figures to the bank every two weeks.

You want to know if the company has any plans to deal with negative changes in the exchange rate with the Chinese Yuan.

You also need some reassurance that the wholesalers Capper Trading are using to distribute the product are reliable and will pay their bills on time.

The bank must decide what it is prepared to offer, and under what conditions.



Being self-employed, your client will have no professional pension on retirement, and so cannot afford to take risks with his / her capital.

The client has sent you an email saying he / she wants you to sell all his / her bonds as the return isn't high enough, and to buy US stocks and / or call options, as the market is rising. At the same time he / she wants to speculate on the dollar continuing to fall in value, by buying put options. He / She also wants to buy commodity futures.

In the meeting you will have to explain to your client that:

- He / She should keep most of his / her capital in high quality bonds, because he / she will need this capital on retirement and so cannot take risks.
- You agree that the US stock market is rising, but think it is safer to diversify by investing a little in a tracker fund linked to the Dow-Jones Industrial Average (which consists of 30 of the largest companies in the US).
- You agree that it is a good time to buy US shares as the dollar has been falling and is currently low.
- Most analysts expect the dollar to start rising again, so this is not the time to speculate on it continuing to fall
- If you <u>did</u> expect the dollar to continue to fall, it would not be a good idea to buy US stocks, as they would be worth less in your currency if you had to sell them.
- You do <u>not</u> think investing (or speculating) in commodities is a good idea as one can easily lose a lot of money this way.

You have a graph to show the client. It shows the volatility of stock markets, specifically how the major stock price index in your country has gone up and down over the past 25 years. This is to demonstrate that it is unsafe to invest only in stocks. You can explain the chart to your client, using some of the language for describing trends and graphs in **Unit 13**.

FAS (Free Alongside Ship) means that the seller's bill only includes delivering the goods to the port. The buyer pays for loading the goods onto the ship (as well as for the transportation by ship). With FOB (Free On Board), the seller pays for loading the goods onto the ship, and includes this in the price.

DEQ (Delivered Ex Quay) means that the seller's price includes the cost of unloading the goods from the ship at the port of arrival. DES (Delivered Ex Ship) means that the buyer pays for this on top of the amount paid to the seller. This is a similar distinction to the one between FAS and FOB.

The exporter can choose which Incoterm to use; these specify who pays for the insurance. With the E and F terms, the buyer is responsible for insurance. With the D terms, the seller arranges and pays for insurance. With the C terms there is a choice: in CIF and CIP the seller is responsible for insurance, with CFR and CPT insurance is the buyer's responsibility.

DDU and DDP no not apply to goods exported from one European Union country to another, because there are no import duties among member countries. If the seller chooses to use one of the D terms, it would be DAF, DES or DEQ.



You are prepared to pay 7.5% fixed interest, and a 1% arrangement fee for the loan, but will ask for a loan at 6%.





### 1.1 Types of banks

Peter Sinclair:

Well, twenty-five years ago the financial industry in most countries had two key characteristics. One was that pretty well all the banks and financial institutions in that country were owned in that country, and there were few international links — in many cases none. So they were national banks belonging to that country. The other key feature was that financial institutions were specialized, so in Britain we had institutions that lent to people who wanted to borrow to buy houses — that means arranging mortgages — so we had specialized things called building societies doing that. We had retail banks where individuals and companies kept bank deposits and which made loans to cover short-term outlays and in some cases longer-term investment. Then we had another range of institutions like insurance companies to provide life insurance or pensions, and we had investment banks — sometimes called merchant banks. These weren't retail banks; they didn't deal with individuals, they dealt with big companies. They gave the companies financial advice, maybe arranging mergers, or fighting off a takeover bid, and helped to raise capital, for example by issuing shares or bonds.

### 1.2 Going international

Peter Sinclair:

In the old days in Britain, the merchant or investment banks were pretty well all British and there were big boundaries between building societies and insurance companies and all these other types of companies. Well, now if you look at the picture, many banks have become universal banks; perhaps 'banks' is the wrong word. Lots of institutions do all the things that I have just described – insurance, mortgages, advice, raising capital for companies, and retail banking besides, and the other great change is that so many of the financial institutions – and it is not just true of Britain, true of pretty much everywhere else - are now international. So, for example in Britain, two of the big four retail banks have changed ownership: one was taken over by Hong Kong and Shanghai Bank, that was the Midland Bank previously, and it's now changed its name to Hong Kong and Shanghai Bank and it really isn't a British bank any more; and another, National Westminster, was taken over by the Royal Bank of Scotland. But if you look at, say, countries like the Czech Republic or Hungary or Poland or New Zealand too, and plenty of other small countries around the world, all their financial institutions pretty well are now owned by foreigners, by German companies, or French companies or Austrian companies - whatever it might be - and the huge international financial institutions are typically, though not all of them, American; and you can now think of the City of London, the world's leading centre for foreign exchange dealings and a great deal of finance, as rather like Wimbledon. In other words it's a great big international stage, happens to be in London, but most of the players are foreign; they are nearly all foreign companies that do, for example, the investment banking and so many other things.

So internationalization and, if you like, homogenization of these hitherto specialized financial institutions. Those are the two big recent trends.

### 2.1 Arranging meetings

Kim: OK, let's say eleven o'clock. Would that suit you?

Pat: Yes, that's fine, Wednesday at eleven. I'll come over to you. Sorry to mess you around like this.

Kim: No problem. I'll confirm that by email.

Pat: It's OK, I don't need an email – I'll be there. Bye.

### 2.2 Handling information

Customer: Hello, this is Mr Kolodziejczyk. I have a current account and a mortgage with you, and I'm

calling for some information about loans.

Bank: Yes Mr Kolo ..., yes sir, what would you like to know?

Customer: I'd like to borrow £25,000 to buy a boat, and I'd like to know what interest rate you'd charge.

**Bank:** Well, our personal loans currently have a typical annual rate of six point four percent.

Customer: Six point four, yes. But could you tell me about secured loans? I read something somewhere

about them being cheaper.

Bank: Yes, of course. That's right. If the loan is secured against a home, a life assurance policy or

another suitable asset, the typical annual rate is only five percent. What type of security do

you have in mind? Your home?

Customer: Yes, I've nearly paid off my mortgage.

Bank: That would probably be acceptable. And the loan can be for any term up to twenty years. When

and how are you thinking of paying back?

Customer: Well, I'm not sure. I would probably want to repay capital and interest together each month. But

it depends. Maybe I'd prefer to pay the interest only, and to repay the capital after five or six

years.

Bank: OK. Perhaps it would be better if I sent you an application form for a secured loan. Could you

give me your name again?

Customer: Kolodziejczyk. That's K-O-L-O-D-Z-I-E-J-C-Z-Y-K. It's Polish.

**Bank**: Yes, thank you. And your first name?

Customer: Stephen. Well actually it's Szczepan – S-Z-C-Z-E-P-A-N – but these days I spell it S-T-E-P-H-E-N.

You have my address. I'm sure I'm the only Stephen Kolodziejczyk at your branch. But can I leave you a new mobile number? It's zero seven eight, nine one nine, double three seven two.

### 3 Retail banking

Peter Sinclair:

Well, I'm not sure that retail banking is declining. I think in many countries the size of bank deposits, that's the liabilities that the retail banks have, has been growing faster than national income — it's been rising. People are increasingly moving away from currency towards things like bank deposits, that's a slow gradual trend and it's a trend evident in most places, especially the more developing poorer countries, emerging economies and so on.

So I think retail banking has always been regarded as important, but perhaps a little boring for some people. So the real action seems to be more in the big-scale operations with large companies, in huge deals and other kinds of activity which are thought to be more sophisticated and perhaps more rewarding than retail banking. More sophisticated yes, more specialized yes, but not more lucrative, and often more dangerous. Retail banking I think is not in decline; although people have been predicting that it might be at some point, there's no evidence that it is.

### 5.1 Lending decisions

Interviewer:

How do banks decide who to lend to?

Gerlinde Igler:

Normally we analyse the customers. That means that we analyse the annual reports, the figures during the year. We have to analyse how the company will develop in the future. So we evaluate the current situation of the customer and the future situation of the customer.

We also discuss the loan with the customers — what kind of loan is it? Is it a short-term loan or is it a long-term loan? It's very important to know the maturity of this loan. If we lend money for a long time we have to be sure that the customer can repay this loan. Normally the company must be able to repay the loan from the operating cash flow, the EBIT of the company.

Our decision also depends on the bank's portfolio. We finance different sectors in industry, and we've got different limits for the sectors. And if we overstep this limit with the new customer, we need a new approval for the higher limit for the sector, and we have to decide if it's OK to increase the credit limit for the sector.

We also have a rating for each sector, and we have to decide if it is a sector with a good rating or a sector with a bad rating. If you have a sector with a bad rating we normally only finance the best companies in this sector.

Sometimes the customer would like to finance some different transactions in foreign countries. If we finance transactions in Eastern Europe or in Asia we have to look at the country rating and we have to look at the limit for this country. For these countries we have limits or we have no limits. If we don't have a limit for this country we can't finance it – it's too dangerous.

### 5.2 Margins

Gerlinde Igler:

The last important point is that we would like to earn money with the customer [laughs]; we need an agreement about the margin. We have a special system, a special calculation system, in which we calculate the margin, and the margin is added to the cost of funds, and the cost of funds plus the margin is then the interest rate of the customers. We need an acceptable margin.

The cost of funds will depend on the market situation and the bank's rating. If you have a good rating you can get money on the capital markets more cheaply than a bank with a bad rating. Every bank is rated by the international agencies, Standard & Poor's and Moody's. It's a big

disadvantage if you don't have a Triple A rating. You have to pay higher interest for the money you borrow.

We calculate a margin and the margin includes the product costs. The product costs depend on the product the customer will use. Then we have the overhead costs. Overhead costs depend on the situation of the bank. A smaller bank has a lot of overhead costs and a big bank normally has lower overhead costs.

The most important point is the risk costs, because the risk costs depend on the customer's rating. If I have a bad customer and the customer has a bad rating, in this case the customer has to pay a higher margin. If we can get securities or collateral we can reduce our risks, because we can use this collateral if the company goes bust.

But there is a lot of competition between the banks and it's very hard for small banks to get good customers or to get acceptable margins.

### 6.1 A letter of complaint

John:

Hello?

Charlotte:

Hi John, Charlotte here. I've got a very aggressive letter here I've got to answer, and I'd like a

second opinion.

John:

0K ...

Charlotte:

We have a customer whose card was being used fraudulently, until it reached the credit limit. And she was on holiday on a small Hawaiian island and suddenly found her card didn't work,

and didn't have any other way of getting cash.

John:

And we didn't notice anything until too late?

Charlotte:

Well, we did. It's someone ordering things from the internet, to be sent to an address in the States. We've now notified the authorities there and blocked the account. But this happened last year, and the transactions weren't fraudulent. At the time, we contacted the customer and she wrote an angry letter saying, 'Can't I buy presents for friends in America without getting stupid letters from my credit card company?' or something like that. This time, we noticed the transactions but didn't immediately do anything. So suddenly she was on the other side of the world with no money, and she couldn't pay the hotel, and she couldn't get to the airport, and

she missed her flight, and so on, and she says it's all our fault.

John:

And she didn't have any other cards?

Charlotte:

Apparently not, and it took two days for her bank to transfer money to her. It was the weekend,

there's a ten-hour time difference, she couldn't call her bank at night, and so on.

John:

Well, that's unfortunate. But we explain the situation, and tell her that we would have taken action sooner over suspected fraudulent transactions if she hadn't replied to us like that last year. Besides, if a card is being used fraudulently we have to block it, so she'd have been in the

same situation anyway.

Charlotte:

True, but the thing is the customer in question is the daughter of the Chairman of MGS Bank.

She makes quite sure she tells us that in her letter.

John:

[laughs] And he couldn't get money to her for two days?

Charlotte:

Apparently not to Hawaii.

John:

What about her MGS Bank debit card?

Charlotte:

I think she'd reached her limit on that.

John:

Well, that's not our fault, is it? Adapt the standard letter, you know, regretting the

inconvenience, say we're doing everything we can to prevent fraud, etc., but absolutely not

admitting liability. Show it to me before you send it, if you like.

Charlotte:

OK, thanks.

### 6.2 An angry phone call

Customer:

Is that MGS Bank? My name's Hewson and I work at Green's, the garden centre. The police just came round to my house, on my day off, and I was nearly arrested! And it's all your fault, because you haven't got a night safe. I want to speak to the branch manager. Now!

Bank employee:

I'm sorry, Mr Hewson, I can't put you through to the manager at the moment. You'll have to

explain the situation to me.

Customer:

I just did! There were two policemen at my house! Accusing me!

Bank employee:

Mr Hewson, if you could just try to calm down a little and explain the situation to me. I'm not

quite sure I follow you.

Customer:

I told you, it's your night safe. You can't use it. It's boarded over, because they're renovating the

building. So I couldn't put the money in it yesterday afternoon.

Bank employee:

Yes, Mr Hewson, we are renovating the building, and work has been going on for three weeks now. And we notified all our customers about this a long time ago. Now perhaps you could explain exactly what the problem is? Did you take some money home instead of depositing it?

Customer:

Yes, I already told you I couldn't deposit it.

Bank employee:

And this morning your manager checked the account, and the money wasn't there?

Customer:

Yes.

Bank employee:

And he notified the police?

Customer:

Yes.

Bank employee: Customer: He didn't call you first?

Bank employee:

I don't know, my phone wasn't turned on. I told you, it's my day off.

^ .

But you have the money?

Customer:

Yes.

Bank employee:

And you've explained this to the police? And your manager?

Customer:

Yes, but I don't like being woken up by the police accusing me of stealing fifteen hundred

pounds because you don't have a night safe.

Bank employee:

Well, it's true that we don't have a night safe at present, but we do have an automated deposit machine in the self-service area of all our branches, next to the cash dispensers, where you can deposit both notes and coins, 24 hours a day. Are you sure your manager told you to use

the night safe?

**Customer:** 

Er, I don't know. But I still want to speak to the manager! Immediately!

### 7.1 Types of accounting

Eric Sharp:

In general, most of the boring work is done by purchase ledger clerks and sales ledger clerks. These are usually bookkeepers who are not qualified to a high level. The information they produce — which is basically a summary of transactions — can then be interpreted by management accountants. It can then be used by senior accountants at financial controller and director level, both for making decisions on the future of the business, and for advising other parts of the business on how to proceed.

The company's accountants also do an internal audit. The aim of this tends to be to ensure that management have sufficient internal control over what is going on. The aim of the external audit is to ensure that published financial statements give a true and fair view of the company's profit, and of its assets and liabilities.

### 7.2 Financial statements

Eric Sharp:

There are three or four different statements that companies include in their Annual Reports, which shareholders can legally expect to see. The key documents are the profit and loss account, the balance sheet, and a funds flow statement of some kind. In the USA, and under International Financial Reporting Standards, the profit and loss account is called an income statement. This document is fairly self-explanatory: it's income less expenditure. The balance sheet is a statement showing what the company has, and what it owes at the end of the year, while the funds flow statement attempts to show whether the company is generating or consuming cash. The tax authorities require more detail than is given in these documents; taxable profit is not the same as accounting profit, so they will expect to see reconciliations between the two.

### 7.3 Barclays' balance sheet

Journalist:

Large banks these days really do possess and manage vast sums of money. For example, Barclays' tangible assets — the buildings the banks are in, and so on, recorded in the accounts as property, plant and equipment — are only worth two point seven five four billion, but the group's total worth, or their shareholders' equity, is twenty-four point four three billion. Their total assets are nine hundred and twenty-four billion, three hundred and fifty-seven million pounds. Barclays' customers have deposited two hundred and thirty-eight billion, six hundred and eighty-four million pounds in their accounts, and the bank has advanced or lent its customers two hundred and sixty-eight billion, eight hundred and ninety-six million pounds. These really are huge figures.

### 8.1 Greeting people and making introductions

Michael:

Excuse me, are you Mrs Steiner?

Monica:

Yes. Hello.

Michael:

Hi. I'm Michael. Welcome to New York.

Monica:

How do you do? But please call me Monica.

Michael:

Sure. Monica, do you know Siobhan?

Monica:

Hello, nice to meet you.

Siobhan:

Hi. How are you?

Monica:

Fine, thanks. I'm sorry, I didn't catch your name.

Siobhan:

Siobhan. It's Irish.

Michael:

We have a car outside. Can I take your bag?

Monica:

Thank you.

Siobhan:

How was your flight? You must be tired. No, I slept a little on the plane. I'm fine.

Monica: Siobhan:

OK. Well, we'll take you to your hotel. Is this your first time in New York?

Monica:

Oh no, I've been here a couple of times. But on vacation, not on business.

Michael:

Not in November, I guess. I hope it's not too cold for you.

Monica:

No, it's fine. It was almost the same in Zurich, actually.

### 8.2 Talking about your career

Michael:

How long have you worked in the finance department at Head Office?

Monica:

Two years. I applied for a job there in my last year at university, when I was studying finance and economics, but I didn't even get an interview. So I went to London and worked as a trainee in a British bank for six months. After that I joined a Swiss bank where I worked in the corporate department. Then I was transferred to their trade finance department. But I didn't get promoted so after three years I applied to this company again, and they offered me my present job. I really like what I'm doing now. I find financial planning really interesting. I'm responsible for some very big projects. What about you?

Michael:

Well, I studied accounting at university and then worked for an auditing firm for two years, but I didn't like it. So I did an MBA, and then got a job here. Now, as you know, I'm in production and operations. I'm in charge of setting up new production facilities here, which is why I'm working on this project with you, and I'm also involved in two projects in Canada. Which means I'm always dealing with lots of problems at the same time. But I enjoy the challenge!

### 8.3 Saying goodbye

Monica:

I'm afraid I have to go now, but it's been a very useful meeting.

Michael:

Of course. Yes, it's been very interesting working with you.

Monica:

And I look forward to seeing you in Zurich next month. You've got my card, but let me give you

my mobile number. Have you got a pen? It's 074 433 ...

Michael:

074 433 ...

Monica:

... 1991. Got that?

Michael:

1991. Thanks. If you'd like to wait in reception, the taxi will pick you up from just outside.

Monica:

Ah, good. Thanks for organizing that.

Michael:

No problem. See you in Zurich. Goodbye, and have a good flight!

Monica:

Thanks. Bye.

### 9.1 Monetary policy

Kate Barker:

At the Bank of England, in common with most central banks round the world now, when we look at monetary policy, it involves changing interest rates.

The aim of monetary policy is to keep inflation low and stable. When you're setting interest rates, what you're trying to do is to keep demand in the economy, what people consume, how much they invest, in line with the long-term ability of an economy to supply goods and services through labour, through people employed, and through the capital employed, machinery, plant and equipment in the economy.

When interest rates rise, this will mean that individuals will tend to save more and consume less. Also for companies, investment decisions are more expensive and that means that demand will tend to be reduced. When interest rates are cut, the opposite happens — people will spend rather than save and companies have more of an incentive to invest, and that means that the level of demand rises. And it's by trying to set demand, to keep demand in line with supply in future, so that the central bank is always looking ahead.

When the central bank sets the base rate for lending to commercial banks, it affects the whole structure of interest rates in a country. For example, in the United Kingdom one of the things it affects very quickly is the rate at which the banks and other organizations lend to households

for their mortgages, but of course it will also affect the rates at which companies borrow. Of course that just means that the central bank controls the short-term interest rate. What happens to other interest rates, one-year, five-year, ten-year interest rates, can be quite different.

## 9.2 Saying figures

#### 10.2 Interruptions and digressions

Alice Hewlett:

So, as I was saying, because the staff of both companies already speak excellent English, and have already had intensive courses about British culture, they only need to learn about our bank, and our products and services. Consequently, training costs would be very low ...

Susan:

Yeah, but you're forgetting the cost of laying off all our call centre staff in Britain.

Chair:

Susan, you didn't let Alice finish.

Alice Hewlett:

Thank you. I'd like to add that I was easily able to find out that the starting salary for call centre staff in both cities is about 8,000 rupees a month, although the average salary is about 10,000 rupees, which is about \$220. So I think that both quotes we've had are rather high, and

I'm sorry, Susan, but that's not the question we're considering today. We're talking about the financial implications of contracting out our telephone operations. Does anyone have anything else to add on this topic? No? Well, Alice, can I just summarize the main points you've made ...

## 11 Asking for information about bills of exchange

Bank advisor:

Trade Finance. Can I help you?

Customer:

Hello, I'm calling from Capper Trading. We've just had a large export order – our first, in fact – and we're planning to use a bill of exchange or a bank draft. Unfortunately, I'm not at all clear

about some of the conditions.

Bank advisor:

Well, perhaps I can clarify them for you. That's what I'm here for!

Customer:

OK. Your instructions talk about the drawer, the drawee and the payee. But aren't the drawer

and the payee the same thing?

Bank advisor:

No. The drawer is the party that issues a bill of exchange, and the payee is the party to whom

the bill is payable.

Customer:

Sorry, I don't quite follow you. Surely the bill is payable to us, as we're the seller?

Bank advisor:

Well, that depends whether you use a bank draft or a trade draft. A bank draft is payable to the

bank. Unless you use a trade draft, issued by you.

Customer:

Er, could you go over that again, please?

Bank advisor:

If you use a bank draft, the buyer pays us, and then we pay the money to you, less any charges

 $\ due\ to\ us.\ If\ you,\ the\ exporter,\ issue\ the\ bill,\ it's\ referred\ to\ as\ a\ trade\ draft,\ and\ it's\ payable\ to$ 

you.

Customer:

Oh, I see. And if you issue the bill, it's generally payable 30, 60 or 90 days from the bill of lading

date, is that right?

Bank advisor:

Yes.

Customer:

What exactly does that mean?

Bank advisor:

The bill of lading is a document that the ship's master signs, acknowledging that the goods

have been received for shipment, describing them, and giving details of where they are going.

But of course you can always get the bill endorsed.

Customer:

Sorry, did you say 'endorsed'?

Bank advisor:

Yes, you can endorse it to the bank.

Customer: Bank advisor: Could you explain that in more detail? Yes. We can endorse the bill before it matures. That means we guarantee to pay the bill if the

buyer doesn't. Then you can sell it at a discount in the financial markets.

Customer:

I don't quite see what you mean.

Bank advisor:

It means you can get most of the money immediately, and you don't have to wait for the buyer

to pay the bill. For example, you sell the bill at 99%, and the discount represents the interest

the buyer could have received on their money until the bill's maturity date.

Customer:

Oh right. OK, thank you very much.

Bank advisor:

My pleasure. Goodbye.

## 12 Concluding a meeting

Chair:

I'm sorry, John, but I'm afraid we'll have to bring this point to a close. I think we've covered everything, and it seems that we all agree on the way ahead, so I'd like to go over the decisions we've taken.



We're going ahead with the plan to redesign and refurbish some of our branches and to relocate the others. John is going to look into the question of finding more suitable premises for the branches in List B, possibly in shopping centres, and contact property agencies. Julie will contact the company that designed our most recent branches, and also investigate their main competitors in the refurbishment business. Remember, we need a company that specializes in banks because of the security aspects, and preferably one that can arrange to do the building work out-of-hours — in the evenings and at weekends — so that normal trading can continue. Alan, you're going to see if any more market research data is available about customer expectations. Claire, you're responsible for getting more information about what facilities the back office staff in the branches in List A would like from a major modernization or upgrading.

## 13 Freely floating exchange rates

Peter Sinclair:

I think a lot of people would say that there's been an important trend towards more flexibility in exchange rates. So, for example, the pound now floats freely in terms of other currencies, the central bank doesn't intervene — only very, very rarely — and that's true for an increasing number of countries.

... the market system is now doing, say in the case of sterling, what central banks and finance ministries used to do in the past, which is trying to pick and stick to an appropriate level for the currency. But there are problems with the markets: markets are not perfect. One problem is that nobody knows the future and if there is an unexpected piece of news about a country, say you discover a vast amount of oil or the government suddenly falls and is likely to be replaced by one which has a very different financial, tax, or monetary policy, then everybody will suddenly wake up and say, 'Hey this is a country whose currency we must buy lots of' or 'This is now really unsafe, we must get out.' And the swings in exchange rates can be absolutely enormous, you can see a currency go up or down by one, two, three percent maybe in a day, in response to certain news.

... a lot of the people who are operating in foreign exchange markets don't tend to think so much about the long run and what the currency really ought to be worth in order for its goods to be priced at the right level in foreign markets and so on. They're trying to guess very short-term trends, and they're trying to guess the hunches of other traders. They tend to say, 'Oh, let's see, if something is going up today it will probably go up tomorrow.' They just go in one direction and you often get huge exchange rate swings, going on for maybe even years, certainly for weeks and months, which are pushing the currency away from what it really ought to be. This is a source of worry and it's undoubtedly happening and it's due to the fact that people don't have perfect information and often tend to say, 'Well, if he's doing this then he must know something I don't, I'd better copy him', and that can be a recipe for real trouble.

#### 15 Market report

Reporter:

In Tokyo today, the Nikkei 225 was firmer at eight thousand five hundred and sixty-nine point three three. Stocks around Europe also advanced this morning, following Friday's late surge on Wall Street, when the Dow-Jones gained eighty points. In Paris, the CAC-40 is up twenty points, although France Telecom plunged three euros fifty to thirteen fifty-five after the company issued a profit warning, and Thomson dropped one per cent to eighteen point thirty-four. The DAX in Frankfurt is also up, by thirty-six points, although Lufthansa tumbled four per cent to seven point fifteen. In London, the Footsie 100 has climbed to four thousand two hundred and twenty point one. British Energy jumped to five pounds twelve after they published their sixmonthly results. Notable losers in London, however, include Vodafone, which slumped to one pound sixteen.

On the commodity markets, copper, which seemed to be going through the roof last week, is steady at seventy-nine point seven cents a pound. Gold has slipped to three hundred and sixty-two dollars an ounce, while silver is almost unchanged at four point forty-four.

#### 16.1 Catering choices

Project Manager: So, any surprises?

HR manager: No, not really. Well, yes, actually - the response rate. It was extremely high. We sent the

questionnaire to about 50% of the staff, and got nearly 3,200 responses – that's around 80%.

Project Manager: That's very good. So what do they want?

HR manager: Food! And lots of it! There's a clear demand for both a staff restaurant, serving hot and

cold lunches, and for coffee and sandwich shops. Most respondents already working in departments with restaurants say they only eat out once a week, on average. But they also say they wouldn't choose the same lunch option every day. They clearly expect a building with

8,000 people working in it to provide them with several choices.

Project Manager: Well that's OK, isn't it? That's more or less what we're already planning.

Yes, but there's also a significant demand for breakfast as well - both cooked breakfast and HR manager:

coffee and pastries. Though on the other hand around 30% said they were likely to bring in their

own lunch most days, and would like fridges and microwaves near their offices.

Project Manager: That's fine – it still leaves over 5,000 people to feed. And breakfast is no problem once you

have the staff and the facilities. At the moment we're thinking of an 850-seat restaurant, serving around 2,500 meals daily, about three-quarters at lunchtime. In fact it'll be one of the

largest restaurants of its kind in the country. In the world even.

#### 16.2 Health and leisure needs

Project Manager: OK, what was next?

Well, after they've eaten they seem to want to sweat it off! Over 90% are in favour of a gym, HR manager:

> especially the female respondents. They want rooms for a range of exercise classes (aerobics and yoga and things), as well as full gym equipment like weights and running machines. Less than 20% asked for squash or badminton courts, so I'm not sure we need to plan those, but

- wait for it - about 50 people said they would like a swimming pool!

Project Manager: A swimming pool? Where do they think we're going to put that?

HR manager: Er ... on the roof!

Project Manager: Oh dear, I think we're going to have to disappoint 50 people! Now, tell me about medical and

health care.

Well, I was a bit surprised, but hardly anyone expects a diagnostic doctor service or dental HR manager:

treatment. Most people said they prefer to have only one doctor, and to get treatment near where they live. There were also concerns over patient confidentiality.

Project Manager: Yes, that doesn't surprise me. Most people don't want their employer to have access to their

medical records. I guess we'll simply abandon that idea.

HR manager: Yet over 65% were in favour of a health clinic for things like travel advice and inoculations. And

8% want cycle parking and changing facilities. This is higher than we expected.

Project Manager: These people who cycle in Manhattan – they amaze me. But we'll clearly have to do something

about that. Eight per cent of 8,000 is a lot. Anything else?

HR manager: Well, 200 people want their own space in an underground parking lot, even though we

specifically said this isn't an option.

**Project Manager:** I can understand that – I'd like one too! But like you say, we can't even think about that.

HR manager: And about 100 people – I know that's not a lot – want a convenience store where they could get things like newspapers and magazines, candy, cans of soda and 'emergency' purchases

have them in hotels with much fewer people.

**Project Manager:** True, but we're not building a hotel. Our people will be working and not shopping most of the

day. Anything else?

HR manager: Yes, the 'Do you have any other concerns?' question showed that there are a number of things

the staff are worried about. Understandably, a lot of respondents voiced fears about a terrorist attack, and want a lot of information about evacuation arrangements and fire precautions. I think we'll have to send everybody a special booklet about this, explaining what the architects

like tissues and headache tablets. I guess 8,000 customers is enough for a store like that; they

are doing.

Project Manager: Yes, that's a good idea.

HR manager: And a lot of people seem to be worried about the time it will take to move around within the

building. Most of them have never worked in a forty-storey high-rise, and certainly not in one with so many people working in it. This building is going to take some getting used to.

#### 17 The role of banks

Peter Sinclair:

Well, the role of the investment banks; yes, they're certainly big, important players in mergers and acquisitions, and yes, they may sometimes try and drum up business, but I think that no well-run firm will want to engage in this kind of activity unless they see merit in doing so. So it isn't all driven by the banks.

What we do note – and that is really interesting – is that when a company goes for a takeover, tries to take over another, the thing that's most important is its share price, the share price of the company doing the takeover. So if the share prices do well – which they did in the 80s and 90s, most of the time – companies feel richer, their shares are more valuable, so they tend to go out on a buying spree and they will get advice from big investment banks and merchant banks about when to buy and what to buy. And the potential victim of a takeover bid will obviously want to get advice from another national institution about how to defend itself, assuming that's what it wants to do.

So we've seen a lot of acquisitions and mergers, some friendly mergers and some contested takeovers, a lot of them happening in a strong stock market. In the early twenty-first century, so far, we have been seeing share prices slide a bit and so mergers and acquisitions are becoming less frequent and of course less valuable. The value of companies has fallen so the

value of the activity for the merchant banks, investment banks, has been slipping too. It is very much a cyclical phenomenon – boom for shares means more takeovers, slump for shares means less.

#### 18.1 Conditional offers

Administrative Director: OK, I'm going to be direct about this. We need your offices to use as conference rooms

for meetings with customers. I'm sorry to say this, but they're much too nice for an IT department! So we're asking you to relocate to some offices we've rented across the street. Of course this is only temporary, as we're all moving to the new building in a

year's time.

IT Manager: And why can't you use the offices across the street as meeting rooms?

Administrative Director: Because they're a bit small. And dark. Two of them don't actually have any windows.

IT person: You must be joking. We couldn't agree to that. Why would we go there?

IT Manager: No, wait a second. We would consider a temporary move on condition that we get much

larger offices in the new building.

Administrative Director: I'm afraid 'much larger' is out of the question. But we'd be happy to discuss the size of

your offices in the new building as long as we can have your current offices before the

end of the month.

IT Manager: I'm afraid we can't accept that. Discussing the size will not be enough. I say 'much

larger' because as you know we are understaffed. We would agree to move temporarily provided that we got the go-ahead to hire the software designer and the systems

analyst we need. Who would obviously require offices.

Administrative Director: Well, we could offer you two extra offices, so long as no other department objects, but

as you know I can't make staffing decisions.

IT Manager: I'm sorry, but we wouldn't consider moving now unless you can guarantee us both the

staff and the space we need.

Administrative Director: Well, I'd be willing to take your request to the next Board meeting if you agreed to move

out on the 26th. What would you say to that?

IT Manager: I'm afraid that still doesn't meet our requirements.

### 18.2 Should we grant this loan?

Sally: So, Chris, the situation is this. Capper Trading has the exclusive rights to manufacture Moggles

toys, to go with a new children's cartoon series on the television. I don't know if you've heard of

it ...

Chris: No.

Sally: Well it goes out every day, early in the evening, and the kids seem to love it, and the toys

based on the series — they're little plastic figures — are selling really well. But Capper can only produce 20,000 a week. They don't want to take on extra staff and run two shifts in the factory, because they don't know how long these toys will go on selling. So they want to subcontract to a company in China, and they want to start immediately. They have a company lined up, but they're going to have to pay them 60 days after the first shipment, and they don't

have a big enough cash flow.

Chris: OK, so how much cash do they currently have?

Sally: Well, none. But that's because they're too successful! They've spent all their money on raw

materials, and they're making these toys, and they're selling as fast as they can supply them,

but the wholesalers haven't paid them yet, and they need to import more.

Chris: Have they got firm orders for the toys they want to import from China?

Sally: Yes. For 100,000 toys. But they're sure they'll soon get more orders, when the first ones sell

out. They want to import 500,000.

Chris: Yeah – and what happens if suddenly the series isn't popular any more or all the kids have got

the toys, and your company - what are they called?

Sally: Capper Trading.

Chris: And Capper Trading has to pay for up to half a million toys they can't sell, that they've bought

with our money?

Sally: They don't think that's going to happen.

Chris: Of course they don't. But it could, couldn't it? Look, bring them in, let's have a meeting

tomorrow afternoon.

#### 19 Derivatives

Peter Sinclair:

Derivatives are a very mysterious phenomenon. They are not entirely new but there has been an enormous growth in them recently, and what they are is funny kinds of financial trick which change the structure of risks and returns. Often they promise higher return on average but at the cost of big increase in risk, that's their usual property.

OK, so who buys them and why are they undertaken? Sometimes people undertake financial derivative transactions actually to make themselves safer, to hedge. They've got a bill, let's say, coming up, which has to be paid in US dollars. Well, the sensible thing to do is try and hold some US dollar assets ahead so that if, when the day comes when you have to pay this US dollar bill, the dollar hasn't in the meantime gone up very sharply, which could spell real trouble for you. So hedging is actually an important source of demand for derivatives; and companies can, in appropriate circumstances, make their financial position much stronger and much safer by undertaking these activities. But these derivatives are complicated, they certainly may not be fully understood even by the banks which are rather keen on doing trades in them.

Steve Harrison:

You have to adopt a balanced view of derivatives, because they have had a very bad press. There have been some very well-cited examples of misuse of derivatives, and these have caused problems in the market — potentially they could have caused a lot of dislocation in various markets. But I think we need to recognize that derivatives have been around for a very long time, in various formats, and that used properly they can be a very helpful financial management tool. Derivatives can ensure that some of the unpredictability that occurs in the financial market is hedged, or neutralized, at least to some degree. However, if derivatives are misused, they have the capacity to cause a great deal of damage.

Generally speaking, derivatives are used to protect certain positions, although they can also give you exposure to areas that the bank decides that it wants to have exposure to. With regard to speculation, I think it depends on the degree of speculation. Financial institutions are in the risk and reward business — to get the reward, they have to take a risk. So derivatives are another tool you can use to take risks — to expose yourself to risk in certain areas where you decide to do that.

## 20.1 Concluding an unsuccessful negotiation

Ajay Sharma: The major sticking point at the moment seems to be staff training. What exactly are your

objections to our proposal?

Alice Hewlett: The problem is not with training so much as with staff retention. We are worried that the way

the call centre industry is booming in India, and given the rapid staff turnover, our customers may be talking to people who are quite new to your company and who have not had enough training or experience with our products. We need some guarantees about the people who will

be answering our customers.

Ajay Sharma: I think we both need to give a little ground here. What do you think is a reasonable solution?

Alice Hewlett: That you guarantee that all the employees answering our calls will have had at least three

months' working experience with bank products.

**Ajay Sharma:** Well, I'm sorry, Mrs Hewlett, but we cannot do that. Perhaps we should adjourn to reconsider

our positions? Hopefully we can come back with some fresh ideas.

Alice Hewlett: I'm sorry, but I don't think that would help. I've told you where we stand on this, and we can't

change our position. And if you can't give us a guarantee on this, we'll have to look elsewhere.

I'm afraid that we've reached a stalemate, so I think we should call it a day.

## 20.2 Concluding a successful negotiation

Representative of

computer manufacturer: OK, we can agree to that. The option will run until the end of the year.

Can we just run through what's been agreed? We're going to deliver five hundred T650 workstations at \$1,450 each, in fourteen days — which is to say, the twenty-third of May — with a payment period of 60 days. These workstations will be fully guaranteed for twelve months. And you have an option to buy two hundred more T650s at the

same price until the end of the year.

I expect you'd like that in writing! We'll draw up a full contract. Well, I think we've both got a good deal. I hope this can be the basis for a long-term relationship.

## 20.3 Saturday opening

**Employee A:** I saw the top secret 'Saturday report' today. It's going to happen.

Employee B: Not without negotiations with the staff association, it's not. So what are they planning?

**Employee A:** I can't tell you. I told you – it's confidential!

**Employee B**: Oh, come on.

Employee A: Well, OK. I think they're sending round a circular tomorrow anyway. So, they're planning to open

most branches on Saturdays, from ten till two, and to stay open an hour longer on weekdays.

**Employee B:** And they think they're going to find enough volunteers to work on Saturday?

**Employee A:** Oh no, not volunteers. They want to change all our contracts, though of course not everyone

will have to work at the weekend. At least, not every weekend.

**Employee B:** I don't believe it! What are they offering in return?

**Employee A:** Two hours off – a two-hour reduction in the working week for all staff who work on Saturdays.

Though the new branches will be so nice, people won't want to work less!

Employee B: You must be joking!

Employee A: I am joking. And they're going to create 25 new jobs, or 50 part-time ones. And there'll be an

annual bonus for all staff if sales of banking products increase with the longer opening hours.

Employee B:

Yeah, but what if there isn't any increase in business, and customers just come in at a different

time? On Saturday instead of during the week. There'll be no bonuses.

Employee A:

They're convinced that won't happen.

#### 21.1 Asset management and allocation

Paula Foley:

Asset management nowadays means managing financial assets - excluding real estate, works of art, and things like that. Individual portfolios and institutional funds are very different, because of size and objectives. There are many classes of possible investments in this area: bonds, stocks, cash, precious metals, funds and so on. Each of these classes contains a certain number, and sometimes a very large number, of sub-classes, like categories of bonds or international stocks of various countries.

The problems for managing assets in this area concern, first of all, the objectives of the portfolio, of the client, and its size. The objectives of a private portfolio will depend on whether you invest for retirement or for use in the next few years, for instance to buy real estate. Another major factor is size, because you can easily diversify and then steer a large portfolio, and it is sometimes much more expensive to do so for a small one. This problem of objectives and portfolio diversification has a direct impact on the returns which are needed or expected to meet these objectives and the implied risk of these portfolios, a risk which depends largely on the returns that are expected.

In practice, the two major questions which arise are first, defining a strategy, and second, an investment style. The strategy in fact means asset allocation. You need to decide what proportion of the funds you will invest in those various classes: bonds, stocks and so on. The asset allocation is the key to the performance of the portfolio, whether it is between industries, between countries, or anything else. It is also the heart of the implementation of a reasonable diversification. But mind you, diversification can be overdone, and then it becomes a very expensive and unproductive exercise.

#### 21.2 Investment styles

Paula Foley:

The second point is style, which is very often not recognized by investors. There are a number of styles of investment management, the main ones being first of all, growth investment, which, as the word says, is looking for growth - for capital accumulation - and looks for growth companies in growth industries. The second is value, which is the opposite of growth, which is conservative industries with high asset values and stable or low-growing earnings.

The third main style is the choice between large and small companies, on the equity side. Large companies are supposed to be stable and more reliable; small companies very often give a faster rate of growth, but are more difficult to track and manage.

Another point here is when you have invested your funds, you still have to manage your portfolio, which may take up to a year to build up. There are essentially two ways to manage a portfolio. One is active management, where you buy and sell guite frequently, to adapt your portfolio to your objectives, and to changing market circumstances. The other one is passive investment: you buy and hold, which used to be for many years, sitting on your positions, until things fundamentally changed or bonds came to maturity. This has now been developed into index-linked portfolios, which try to follow stock market or bond market indices, and replicate their movements. This can be a very attractive proposition, or not, considering that these portfolios go down with the market in negative times.

A final important remark is that portfolios which are composed of funds also need to be managed. You cannot buy and sit on a fund portfolio indefinitely. Funds change - they change their management, they change their quality and their objectives; therefore, just like an ordinary portfolio, a fund portfolio has to be managed too.

#### 22 The introduction

Paula Foley:

Good morning everybody. Thank you all for coming today. My name is Paula Foley, and I'm Vice-President for Private Banking. This morning I'm going to talk about conservative portfolio strategies, because most of you are responsible for an increasing number of clients who choose this option. My presentation will take about fifteen minutes, and as you can see, I've divided it into four parts. The first part will be about risk management in general. The second part looks at diversification, which is of course the most important concept of all. Then I'll talk about the use of indexed funds, and finally I'll discuss capital preservation and capital accumulation. If anything isn't clear, or if you have any questions, please don't hesitate to interrupt.

OK. So, what is risk management? ...

#### 23.1 The Financial Services Authority

Steve Harrison:

I think I'm correct in saying that the FSA came into existence on the first of June 1998. It was formed from nine organizations, I believe, although it may be slightly more now because extra responsibilities have been added to its mandate. The creation of the FSA was in recognition of developments taking place in the financial markets, the way firms were organizing themselves. The firms are not just banks any more, they're more like financial conglomerates, and so there needed to be a way to ensure that the supervision of these firms is appropriate.

The firms were becoming more and more integrated, and in order to make financial regulation more efficient, it was felt that the regulator in the United Kingdom should consider doing the same thing. So the decision was made to establish an integrated financial regulator incorporating all of those different elements.

When it's working with banks like ours, the FSA's main objective is to understand the institution, what it's currently doing and what it's seeking to do. The FSA is governed by statutory objectives such as protecting consumers and fighting financial crime. So that underpins all of its work. But the nature of its job, in relation to us, is to communicate with a wide range of people in the institution, both in our compliance department and at very senior executive levels. The FSA needs to understand our strategy as well as what we are doing on a day-to-day basis, in terms of our products and of how we are treating our customers. These customers may be consumers but they can also be what we would call wholesale counterparties – other banks that we deal with on a regular basis.

#### 23.2 Conflicts of interest

Steve Harrison:

... We need to recognize that there have always been conflicts of interest. The crux of the problem is not the fact that we have them, but the way in which firms manage these conflicts of interest.

Often it's about how you control information within financial institutions. Increasingly, different parts of the firm will interact with the same counterparty, but in different ways. For example, there has been a situation in the press regarding equity research, where research analysts have been used almost to promote investment banking. That's caused a number of problems because retail investors — certainly in the USA — have purchased shares in firms on the basis of the research analysts' recommendation. There has been a suggestion that the view the analysts gave on those firms was actually not their real view. Their private view was that the firms were not nearly as attractive as they stated publicly, but they made these statements because there was a chance that if they did, then the firm would give investment banking work to the bank. Statistics in the UK show that the number of buy recommendations on firms substantially outweigh the number of sell recommendations on firms, so clearly there is a balance to be achieved here.

There's also auditing. Certainly a number of auditing firms have realized that the set of skills that they have within the firm means they are often very well placed — and legitimately placed — to provide extra consultancy-style work. Again, that is not necessarily a problem — what needs to be monitored is how this is managed with respect to the relationship with the client of the auditor. But certainly I think it's fair to say that many auditing firms have recognized this conflict in recent years and have either separated their consultancy business from the auditing firm, or have used other techniques to manage the potential conflict of interest. One of those has been, for example, that when they appoint an auditor, many clients now deliberately state that they will not use that firm for consultancy work. They will use another auditing firm for their consultancy work.

## 24.1 Parts of a presentation

Paula Foley:

- ... OK, so as I said, first of all I'm going to talk about financial futures, before moving on to options. As you probably know, futures were first traded on ...
- ... That's all I need to say about futures, so that completes the first part of my talk. Now let's turn to options, which are this department's specialty ...
- ... That's all I'm going to say about options, so unless you have any questions let's move on to the third part of my presentation, which is about swaps. As I said in my introduction, these fall into two main categories: interest rate swaps and exchange rate swaps. I'll begin with interest rate swaps, which some of you ...
- ... So that was interest rate swaps. Now we come to exchange rate swaps, which are still an important derivative instrument, even after the introduction of the euro ...

## 24.2 The end of a presentation

Paula Foley:

OK, that's all I have to say about capital preservation and accumulation, so now I'll just summarize my three main points again. A conservatively managed portfolio should be widely diversified; it should be expected to rise or fall in line with one or more major stock indices; and it's more important to preserve capital than to accumulate it. So, to conclude, I have two recommendations. Firstly, I think we need to diversify our clients' portfolios more widely, probably across more than one stock market. And, secondly, given the current volatility of the markets, I think we all need to pay more attention to preserving our clients' initial capital sums than to increasing them.
